This Waiver and Release Agreement (the "Agreement") is a legally binding Agreement between Club Legacy, LLC. and the Participant and his/her Parent(s) as stated below.

Participant and Parents acknowledge that certain inherent risks and dangers may arise during the training, practice and participation in sporting events arranged, organized, sponsored or sanctioned by Club Legacy, LLC. (LVC). Participant and Parents acknowledge that these risks and dangers may cause or result in serious injury to person or property and possibly disfigurement or death during the LVC events.

Any time a Participant or Parent is uncomfortable in performing any activity at a LVC event, Parent and/or Participant may elect to not participate in such activity and shall immediately notify a LVC representative. Participant and Parent agree to disclose any and all medical conditions related to Participant in any medical information form which may be required and disclose the same to any appropriate LVC representative. Participant agrees that he/she will not participate in any LVC event unless physically and medically able to do so.

Participant and Parents assume all risks and responsibilities for injury related in any way to participation in LVC events. As a condition of participation in LVC events, Participant and his/her Parents forever release and discharge LVC, its directors, staff, coaches, volunteers, employees, representatives and agents, together with the United States Volleyball Association, Amateur Athletic Union, the Legacy Volleyball Center, and any facility owners or lessees where LVC events are being conducted (collectively the "Released Parties"), from any and all liability, claims, or causes of action, in both equity or at law, for injury to person or property that may arise from participation or attendance at any LVC event, including but not limited to claims arising from ordinary negligence, gross negligence, intentional acts, mistakes, act, failure to act, omission, failure to supervise or any other claim of any type or nature.

Furthermore, Participant and his/her Parents agree to hold harmless and indemnify LVC together with its directors, staff, coaches, volunteers, employees, representatives and agents, together with the United States Volleyball Association, Amateur Athletic Union, the Legacy Volleyball Center, and any facility owners or lessees where LVC events are being conducted (collectively the "Indemnified Parties"), from any and all losses, claims, actions, lawsuits, costs or expenses including but not limited to medical expenses, liens, judgments, court costs and all attorney's fees arising from any injury to person or property (including disfigurement or death) asserted by Participant and/or his/her Parents arising out of or in connection with any LVC event, , including but not limited to claims arising from ordinary negligence, gross negligence, intentional acts, mistake, act, failure to act, omission, failure to supervise or any other claim of any type or nature.

This Agreement shall be binding upon the Participant and Parents, as well as the Participant's and Parents' heirs, executors, administrators, personal representatives, and assigns. This Agreement shall be governed by the laws of the State of Michigan. Any litigation involving this Agreement shall be brought only in the Circuit Court for Oakland County at Pontiac, Michigan. If any portion of this Agreement is deemed, by a court of competent jurisdiction, to be void or unenforceable, the remaining provisions shall be enforced to the full extent allowed under Michigan law as if the particular void or unenforceable provisions were not herein contained.

WARNING: THIS WAIVER AND RELEASE ACTS AS A RELEASE OF YOUR RIGHTS. BY EXECUTION OF THIS AGREEMENT, YOU ARE AFFIRMING THAT YOU HAVE READ THIS DOCUMENT AND AGREE TO THE CONDITIONS STATED HEREIN. IF YOU DO NOT UNDERSTAND THIS AGREEMENT, YOU MAY WISH TO CONSULT AN ATTORNEY OF YOUR CHOICE. PARTICIPATION IN ANY LEGACY VOLLEYBALL CLUB EVENT WILL BE DENIED WITHOUT COMPLIANCE TO THIS AGREEMENT.
